The International Economic Accounting and Analytical Forum includes the following events and activities:

1. VII INTERNATIONAL RESEARCH-TO-PRACTICE CONFERENCE "APRIL SCIENTIFIC READINGS APPLIED BY PROFESSOR L.T. GILYAROVSKAYA ", which will be held on April 13, 2018.

The work of the conference will be held in the following areas:

- problems of reforming the local (domestic) accounting system;
- specifics of accounting in organizations of various types of economic activity;
- development of theoretical and organizational-methodical provisions of financial, tax and management accounting;
- directions of improvement of the organization's accounting (financial) reporting;
- organization of accounting, analysis and control in budgetary institutions;
- formation of a controlling system in organizations;
- problems of methodology and methods of economic analysis;

- modern concepts of investment, innovation, financial, on-farm, operational and forecast economic analysis;
- problems of theory and organization of internal and external audit;
- problems of theory and methodology of intraeconomic control of organizations;
- methods of statistical measurement and observation of socio-economic phenomena, etc.

Tables and figures are given in the main text of the article; the font of tables and signatures to the drawings is 12 pt.

Required requisites:

- the title of the article (in Russian and English);
 - surname and initials of the author (in Russian and English);
 - the position, title, full name of the university, institution or organization (in Russian and English);
 - short abstract of the article (in Russian and English);
 - the text of the article;
 - list of used literature.
- * For foreign participants, the full text of the article in English.

Foreign participants are free of charge.

Student work is accepted for publication with the author's participation of their scientific advisors.
